These space saving lamps offer high performance in a small package, offering all the benefits of LED technology including the brightest white light output, low current consumption and a long maintenance free service life.

Installation:

- 1. Select a mounting location for the unit on a flat surface. Place the unit bracket, flat side down, on the surface.
- 2. Use the two circular slots in the bracket to mark the drill locations for mounting. Drill two 0.397 diameter through holes (X drill bit) through the mounting surface. Align the base with the mounting holes, and use 3/8"-16 hardware (include bolts, flat washers, lock washers, and nuts) to mount the bracket to the surface. Position the unit in the horizontal direction, and tighten both nuts.
- 3. To position the unit vertically, use a 5/32" hex L-key to loosen the two screws on each side of the bracket. Tighten the screws when pivoted properly.


